**Sub.: Merger of Piramal Enterprises Limited with Piramal Finance Limited**

Dear Sir / Madam,

We had in our previous analysts/ investors meets and vide specific announcements made on the stock exchanges vide letters dated 11/9/2025 and 16/9/2025, kept the shareholders and investor community informed about the merger of **Piramal Enterprises Limited** (PEL) with **Piramal Finance Limited** (PFL/ Transferee Company) (*erstwhile Piramal Capital & Housing Finance Limited*), and the process which the Transferee Company will have to follow to list its shares on the stock exchanges. Through our last communication we had informed that the Company has fixed 23<sup>rd</sup> September, 2025 as the **record date** for allotting equity shares of PFL to eligible shareholders of PEL.

For the benefit of our investors we wish to reiterate that from the record date, the securities of PEL will stop trading. Shareholders of PEL whose names appear in the register of members on the record date will be allotted equity shares of PFL in the ratio of 1:1 as envisaged in the scheme of merger and other debt securities of PEL will be transferred to PFL.

Upon allotment / transfer, PFL will make necessary applications to list these securities on the stock exchanges. The securities will be available for trading upon these approvals and listing.

The above would only apply to the securities issued by PEL. Existing debt securities of PFL will continue to trade on the stock exchanges.
